**I. NAME**

This auxiliary ministry of the \_\_\_\_\_ Church shall be known as *Great Commission Women of The Christian and Missionary Alliance*.

**II. MISSION**

*Great Commission Women*, an auxiliary ministry of the \_\_\_\_\_ Church of The Christian and Missionary Alliance, exists to glorify God as devoted Christ followers of all generations, empowered by the Holy Spirit to live the Word, do the work, and reach the world.

**PHAAJ I. LUB NPE**

Phaab dlejnum namtsev ntawm pawgntseeg \_\_\_\_\_ muaj lub npe hu ua *Great Commission Women (Cov Namtsev Xaa Moozoo) ntawm Cov Ntseeg Yexus hab Kev Koomteg Qha Txujmoo Zoo*.

**PHAAJ II. TEG DLEJNUM**

*Great Commission Women* (Pawg Namtsev), phaab dlejnum namtsev ntawm pawgntseeg \_\_\_\_\_ ntawm Cov Ntseeg Yexus hab Kev Koomteg Qha Txujmoo Zoo, muaj nyob lug ua kuas Vaajtswv lub npe raug qhuas lug ntawm kev kub sab lug caum Tswv Yexus qaab nyob rua txhua tam, puv npo Vaaj Ntsujplig lub fwjchim kuas ua neej lawvle Vaajtswv Txujlug, ua Nwg teg dlejnum, hab xaa txujmoo zoo moog thoob qaabntuj.

### III. VALUES and GOALS

The *Core Values* of Great Commission Women shall be *active commitment to*:

1. Effective Fervent Prayer
2. Immersion in the Word
3. Intentional Spiritual Formation
4. Spirit Led Giving
5. Faith Filled Risks
6. Heart for Reaching the Lost
7. Spiritual Heritage Emergence

The *Goals* of Great Commission Women shall be:

1. To engage every fully devoted Christ follower of all generations in effective fervent prayer.
2. To encourage Christ followers to seek an intimate relationship with Him through intentional spiritual formation.
3. To reach people by demonstrating God's love and proclaiming His Word.

### IV. RELATIONSHIP

Great Commission Women is part of the National, District and Area (where applicable) Great Commission Women and shall include those who are participant in Great Commission Women in the local churches of The Christian and Missionary Alliance. It is an auxiliary ministry of the local church and is amenable to the pastor and governance authority of the church.

### PHAAJ III. YAAM TSEEMCEE B hab HOMPHAJ

Yaam *Tseemceeb* ntawm Great Commission Women (Pawg Namtsev) yog kuas txhua tug *npuab sab rua*:

1. Kub sab lug thov Vaajtswv kuas tau txais
2. Nyeem hab kawm Vaajtswv txujlug kuas tub
3. Txhob txwm ua kuas luj hlub ntawm saab Ntsujplig
4. Paab nyajtxag le Vaaj Ntsujplig ua tug coj
5. Ua Vaajtswv dlejnum puv npo nrug txuj kev ntseeg
6. Muaj lub sab hlub tshua ncaav kuas cuag tug pluj lawm
7. Koob moov ntawm saab kev ntseeg kws raug rhawv lug

Cov *Homphaj* ntawm Great Commission Women (Pawg Namtsev) yog:

1. Nqegteg coj txhua tug kws kub sab lug caum Tswv Yexus qaab nyob rua txhua tam tig lug kub sab thov Vaajtswv kuas tau txais.
2. Txhawb txhua tug kws caum Tswv Yexus qaab kuas nrhav kev sis raug zoo nrug Vaajtswv lug ntawm kev luj hlub saab Ntsujplig.
3. Ncaav kuas cuag tuabneeg lug ntawm kev ua qauv qha txug Vaajtswv txuj kev hlub hab tshaajtawm Nwg Txujlug.

### PHAAJ IV. KEV FEEMXYUAM

Great Commission Women (Pawg Namtsev) yog ib feem ntawm Koomhum Namtsev Qebsab, Koomhum Namtsev (ntawm Koomhum Moob) hab Cheebtsaam (yog tas muaj) hab cov tswvcuab yog txhua tug namtsev kws tuaj koom (zwm rua) Pawg Namtsev ntawm tej pawgntseeg ntawm Cov Ntseeg Yexus hab Kev Koomteg Qha Txujmoo Zoo. Pawg Namtsev yog ib phaab dlejnum ntawm pawgntseeg hab nyob huv qaab kev tswjfw m ntawm tug xwbfbw hab cov tsaavxwm huv pawgntseeg.

## V. STRUCTURE

### Section 1. Leadership Teams/Coordinators

- a. **Leadership Team.** This ministry shall have a Director (elected, appointed, or hired in accordance with the local church constitution and operating procedures) and a support team to fulfill the vision, mission, values and goals of Great Commission Women. The Director shall serve as ex-officio of all standing and special committees.
- b. **Ministry Coordinators.** Each Great Commission Women Local ministry may have coordinators to oversee various ministries that clearly fulfill the objectives of Great Commission Women.
- c. **Term of Office.** With the exception of a hired Director, the terms of office shall be no more than eight total consecutive years for Director and any leadership team member.

### Section 2. Relationship to Great Commission Women – National/District

- a. Opportunities to participate in Great Commission Women projects and ministries shall be provided by the National and District Leadership Teams.
- b. Each local church auxiliary ministry shall submit an annual report of its ministries and activities to the Great Commission Women District Director.

## PHAAJ V. PAWG NAMTSEV LUB CEV

### Feem 1. Cov Thawjcoj/Cov Tuav Dlejnum Tej Phaab

- a. **Paab Thawjcoj.** Paab thawjcoj yuavtsum muaj tug Thawj Namtsev (kws yog raug xaiv, taw npe, lossis ndlav lawvle pawgntseeg txuj kevcai lijchoj hab kaabke dlha dlejnum) hab muaj cov paab dlejnum ntawm tej phaab lug leg dlejnum rua lub zeem muag, teg dlejnum, cov num tseemceeb hab cov homphaj ntawm pawg namtsev kuas tav. Tug Thawj Namtsev yog ib tug tsaavxwm tshwjxeeb rua txhua paab kaavxwm hab cov kaavxwm tshwjxeeb.
- b. **Cov Tuav Dlejnum Tej Phaab.** Txhua pawg namtsev ntawm pawgntseeg yuav tau tsa muaj cov tuav dlejnum tej phaab lug saib pawg namtsev lub luag dlejnum kuas tav.
- c. **Noobnyoog Ua Dlejnum.** Taagnrho cov noobnyoog ua dlejnum rua tug Thawj Namtsev hab lwm tug tsaavxwm tsi pub tshaaj yim (8) lub xyoos sis law. Tsuas tshwj tug Thawj Namtsev kws raug ndlav lug ua dlejnum xwb.

### Feem 2. Feemxyuam rua Koomhum Namtsev Qebsab /Koomhum Namtsev (ntawm Koomhum Moob):

- a. Cov homphaj hab dlejnum kws pawg namtsev muaj feem koomteg ua yog paab Thawjcoj Koomhum Namtsev Qebsab hab Koomhum Namtsev (ntawm Koomhum Moob) ua cov npaaj.
- b. Txhua pawg namtsev ntawm pawgntseeg yuav tau tshaabxu txwmxyoo txug cov dlejnum kws pawg namtsev ua xaa moog rua Thawj Namtsev ntawm Koomhum (Moob).

### Section 3. Records

- a. The official records of all team members are the property of Great Commission Women Local ministries. All financial records shall be audited annually or at a time designated by the Pastor and/or the governance authority of the church.
- b. In the event of the death or resignation of the incumbent, or upon the election/appointment of her successor, the current records necessary for fulfilling the obligations of the team member's position shall be passed on to the newly elected/appointed team member.

## VI. MEETINGS

**Section 1. Great Commission Women Meetings.** Great Commission Women are encouraged to meet regularly to accomplish the objectives. Such meetings shall be the responsibility of the Director and her Leadership Team with the approval of the Pastor. Any business pertinent to the organization may be conducted on these occasions.

**Section 2. Meetings of the Local Leadership Team.** The Local Leadership Team shall meet as needed at the request of the Director or the Pastor.

### Feem 3. Tej Ntaub Ntawv

- a. Txhua yaam ntaub ntawv tseemceeb ntawm txhua tug tsaavxwm yog pawg namtsev le teejtug. Txhua yaam ntaub ntawv nyajtxag yuavtsum raug tshuaj ib xyoos twg ib zag lossis tshuaj lawvle xwbfbw hab/lossis lub rooj tsaavxwm huv pawgntseeg pumzoo kuas tshuaj.
- b. Tau yog ib tug tsaavxwm twg taag simneej lossis su nwg teg num, lossis nwg raug xaiv/taw moog rua lwm lub meejmom, txhua yaam ntaub ntawv kws tseem yuav siv rua lub luag dlejnum ntawd yuavtsum tau muab cob rua tug tsaavxwm tshab kws raug xaiv/taw lug hloov chaw.

## PHAAJ VI. KEV SAABLAJ

**Feem 1. Kev Saablaaj ntawm Pawg Namtsev.** Nqua hu kuas pawg namtsev yuav tau muaj kev saablaaj ua ntu zug lug txhawb tej homphaj kuas tav. Tej kev saablaaj nuav yog Thawj Namtsev teg dlejnum hab nwg paab Thawjcoj nrug rua kev pumzoo ntawm tug xwbfbw. Tej dlejnum tseemceeb kws yuav txhawb lub koomhum yog thaam rua lub sijhawm nuav.

**Feem 2. Kev Saablaaj ntawm Paab Thawjcoj Pawg Namtsev.** Paab Thawjcoj pawg namtsev yuavtsum tau saablaaj yog hastas tug Thawj Namtsev lossis xwbfbw xaav kuas muaj.

## VII. FINANCE

**Section 1. Team Members.** The ministry of the Local Leadership Team shall be considered a service to Christ and the Church and shall be without financial remuneration beyond expenses incurred. The exception to this model would be if the Director is a paid staff member of the church.

**Section 2. Ministry Fund.** An annual budget proposal shall be prepared, presented and adopted by the GCW Local Leadership Team in consultation with the church governance authority to fund GCW Local initiatives and planning. Subsequently, an annual audit shall be completed to verify the use of funds.

**Section 3. National Ministry Fund.** Great Commission Women Local ministries shall be requested to make an annual monetary contribution to the Great Commission Women National Ministry Fund to provide for the ministry functions of the National Executive Team.

**Section 4. District Expenses.** Great Commission Women Local ministries shall be requested to make monetary contributions to the ministry fund of the District Leadership/Executive Team, to the funds used for district overseas workers, and to any other approved district projects.

## PHAAJ VII. NYAJTXAG

**Feem 1. Paab Tsaavxwm.** Kev ua dlejnum ntawm paab Thawjcoj pawg namtsev yuav tau suav hastas yog ib teg dlejnum ua pub rua Tswv Yexus hab pawgntseeg hab yuav tsi muaj kev siv nyaj ua nqe zug rua puab. Tshwj tug Thawj Namtsev yog hastas nwg raug pawgntseeg ndlav lug ua dlejnum.

**Feem 2. Nyaj Dlha Dlejnum.** Paab Thawjcoj pawg namtsev yuav tau npaaj, qha hab txais yuav peev nyaj komtseg lug siv rua pawg namtsev dlha dlejnum txhua lub xyoos, nrug rua kev pumzoo ntawm lub rooj tsaavxwm huv pawgntseeg. Tom qaab ntawd, ib xyoos twg yuav tau tshuaj ib zag txug kev siv cov nyaj ntawd.

**Feem 3. Nyaj Rua Koomhum Namtsev Qebsab Dlha Dlejnum.** Txhua pawg namtsev ntawm pawgntseeg yuav tau paab nyaj ib xyoos ib zag moog rua Koomhum Namtsev Qebsab peev nyaj dlha dlejnum kuas paab tsaavxwm KHNQS tau siv ua cov dlejnum kws puab tau komtseg.

**Feem 4. Nyaj Rua Koomhum Namtsev (ntawm Koomhum Moob) Siv Dlha Dlejnum.** Pawg namtsev ntawm pawgntseeg yuavtsum paab nyaj rua kev siv dlha dlejnum ntawm paab Thawjcoj/paab Tsaavxwm Koomhum Namtsev, cov nyaj nuav Koomhum Namtsev yuav siv moog paab rua koomhum cov xwbfbw kws ua dlejnum txawv tebchaws, hab rua cov dlejnum kws lub Koomhum tau pumzoo yuav ua.

**Section 5. Projects.** Great Commission Women Local ministries are requested to support the Great Commission Women National Project. Other church-wide appeals for funds shall be approved by the governance authority of the church.

### **VIII. AMENDMENTS**

These policies may be amended by the Vice President for Church Ministries with the approval of the Board of Directors of The Christian and Missionary Alliance.

### **IX. OPERATING PROCEDURES**

Operating procedures not in conflict with these policies may be adopted at any regular meeting of Great Commission Women Local ministries by a two-thirds vote of the members present. Proposed Operating Procedures shall be submitted to the governance authority of the church for approval before being adopted.

**Feem 5. Nyaj Paab Rua Cov Homphaj Dlejnum ntawm KHNQS.** Pawg namtsev ntawm pawgntseeg yuav tau paab txhawb cov homphaj dlejnum kws Koomhum Namtsev Qebsab rhawv muaj. Yog lwm pawgntseeg muaj kev thov nyaj lwm yaam yuavtsum yog lub rooj tsaavxwm huv pawgntseeg tso cai.

### **PHAAJ VIII. KEV HLOOV**

Tug Lwm Tsaavxwm kws saib phaab Cov Pawgntseeg Kev Ua Vaajtswv Dlejnum txhaj muaj cai hloov cov kevcai tswjfwv nuav nrug rua kev pumzoo ntawm lub Rooj Tsaavxwm ntawm Cov Ntseeg Yexus hab Kev Koomteg Qha Txujmoo Zoo.

### **PHAAJ IX. KAABKE DLHA DLEJNUM**

Pawg namtsev muaj cai txais yuav cov kaabke dlha dlejnum kws tsi cuam tshuam nrug cov kevcai tswjfwv nuav lug siv thaus pawg namtsev muaj kev saablaaj yog hastas muaj suab txug ob feem peb (2/3) ntawm cov namtsev kws tuaj saablaaj (sis txoos uake) pumzoo lawm. Yog muaj tej nqai kaabke dlha dlejnum kws xaav muab khu/ntxiv yuavtsum tau muab nqai ntawd xaa moog rua lub rooj tsaavxwm huv pawgntseeg nrug pumzoo uantej yuav txais lug siv.
