#### **B.** OTS Restructure

More than 20 years ago, Overseas Tribal Services (OTS) was established to serve and support global humanitarian efforts which the Hmong District has long supported. Due to a need for strategic realignment and financial instability, the OTS Board proposed restructuring OTS under the Hmong District. This integration will enhance efficiency, ensure sustainability, and align missions.

After consultation with the National office and deliberation, DEXCOM approved the restructure, placing OTS under the Missions Department while allowing it to retain its 501(c)(3) status, following the model of CAMA services.

This change will be effective on August 1, 2025.
