Milwaukee, WI Ministry Strategy Meeting Minutes SESSION 4 Thursday, June 23, 2025

1. Call to Order

- a. The Moderator, Reverend Toua Thao called the meeting to order at 10:45 AM after quorum was established.
- b. Reverend Teng C Herr (Kx. Tsaav Teev Hawj) opened with prayer.

2. Agenda Committee

- a. The Agenda Committee was called and presented the following agenda for adoption:

- b. Motion: Reverend Chou Xiong motioned to allow DEXCOM to review and approve meeting minutes. Motion second. Motion adopted.
- c. The proposed agenda was moved for adoption. Motion adopted.

3. Credential Final Report

- a. The Rules and Credentialing Committee was called. The final reading of the committee was presented.
- b. The final credential reading was moved for adoption. Motion second. Motion adopted.

4. Election: Nomination Committee

- a. The Nomination Committee was called.
- b. The Nomination Committee read from the bylaw in Art. III, Sec 1.F: Election Rules.
- c. MOTION: The Nomination Committee motioned that the 2 candidates with the most votes, instead of a majority, be declared the winners of the election in their respective positions. Motion second. Motion adopted.
- d. Election
 - 1. DEXCOM Pastor: Elijah Vang
 - 1. The floor voiced approval. Reverend Elijah Vang was declared the winner.
 - 2. DEXCOM Layman/Elder:
 - 1. Voting rules were read.
 - 2. Candidates presented.
 - a. Mr. Chue Thao
 - b. Mr. Ber Xiong
 - c. Mr. Fong Thao
 - 3. Prayer for election: Pastor Fue Thao (Xf. Saub Fwi Thoi)
 - 4. 1st Ballots were cast.

5. Final Words: Moderator

- a. Reverend Toua Thao expressed gratitude for trust and participation, highlighting
 - 1. Reduction from seven to four business sessions.
 - 2. Recognition of all committee members' hard work.
 - 3. Emphasis on transitioning towards a spiritual and less parliamentary Robert's Rule of Order.

6. Closing Address: District Superintendent Reverend Lantzia Thao

- a. Encouraged by the delegates' spiritual and simplified approach during business meetings instead of holding to strict Robert's Rules of Order.
- b. Vision cast for missions and evangelism, especially outreach to unreached people in Thailand, Vietnam, and continued global partnerships in Australia, Canada, and France.
- c. Called for unity and collective commitment to the next 75 years of missions.

7. Recess: 11:37 AM - Reverend Toua Thao called for a 3 minute recess.

a. At 11:40 AM the session resumed after quorum was established.

8. Election Results: Nomination Committee

- a. DEXCOM Pastor: Reverend Elijah Vang was declared the winner, as confirmed by voice vote.
- b. DEXCOM Layman:
 - 1. Total ballots printed: 370 ballots for the 368 accredited delegates (2 extra ballots were printed for unexpected needs).
 - 2. Mr. Chue Thao: 193 votes
 - 3. Mr. Ber Xiong: 217 votes
 - 4. Mr. Fong Thao: 99 votes
 - 5. Abstain: 12 votes
 - 6. Total Ballots Cast: 276
 - 7. Ballots that were left blank: 94 out of 370
- c. At 11:55 AM, motion to extend for 3 min. Motion second. Motion approved
- d. At 11:58 AM, the session resumed after quorum was established.
- e. DEXCOM Elders/Laymen: Mr. Chue Thao and Mr. Ber Xiong were declared the winners according to the ballot results.
- f. Election Results were confirmed by Corporate Secretary Reverend Tom Yang, Nomination Committee Chairman Yee Heu, and Usher Committee Chair Nao Vang.

9. Adjournment/Closing Prayer

- a. The session was adjourned at 11:58 AM.
- b. Reverend Dr. Nha Long Yang closed with prayer.
